

ACT Pre-Learner Licence Course Information & Enrolment Form

The ACT Pre-Learner Licence Course (PLLC) is more than just a training session for people to learn about the ACT road rules. Knowing the road rules is important, but so is knowing how to be a safe, accountable, and responsible member of the ACT road user community. The course is a classroom style education program that is required to be completed by ACT residents applying for an ACT Learner Licence (L's) as part of the graduated licencing scheme.

The course is made available by the Youth Engagement Team* (YET) to all young people aged 15 -25 years and is facilitated by trained staff over 2 consecutive days. Attendance of both days and a final multiple-choice assessment is compulsory in order to successfully complete the course. Once the course is completed, an online Road Rules Knowledge Test is required and will be facilitated on the afternoon of the second day.

The content and activities delivered in the course are designed to help young people understand that holding a driver's license is a privilege that comes with the responsibility to be accountable, respectful, and safe on the road.
